Staff reviewed the application for transfer (application) submitted on March 12, 2018, on behalf of Kincaid Hills Water Company and Gator Waterworks, Inc. (Applicant or Buyer). After reviewing this information we find the application to be deficient. The specific deficiencies are identified as:

1. **Buyer Documentation.** Rule 25.30.037(2)(p), F.A.C., requires a statement from the Buyer that it has obtained or will obtain copies of all of the federal income tax returns of the seller from the date the Utility was first established, or the rate base was last established by the Florida Public Service Commission (Commission), whichever is later. If the tax returns have not been obtained, provide a description of the steps taken to obtain the tax returns. Although the application provided that the Buyer has obtained the federal tax returns from 2016, please provide a statement that the Buyer has or will obtain, copies of all of the federal income tax returns from the federal income tax returns from the tax returns have not been obtained, please provide a statement that the Buyer has or will obtain, copies of all of the federal income tax returns from the date the Utility was first established, or the rate base was last established by the Commission, whichever is later.
