On April 16, 2018, in response to the 2018 Local Competition Report data request, Windstream Florida, LLC filed the Local Competition Report questionnaires and FCC Form 477s on behalf of DeltaCom, LLC d/b/a Earthlink Business (TX056) and EarthLink Business, LLC (TX380). Windstream claimed confidentiality for each submission, but did not indicate for which documents the claim of confidentiality covered.

Staff contacted Windstream via email to request specificity in the claims for confidentiality, and the company responded that the claim covered only the FCC Form 477 line data, and not the data request questionnaire.

Staff requests the attached email be placed in Docket 20180000-OT and cross reference the description of the following documents:

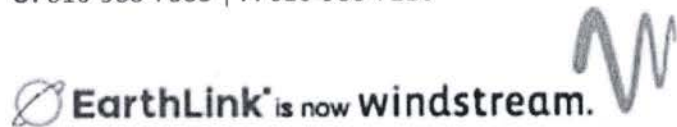
