2	CHAIRMAN GRAHAM: Okay. Let's circle back
3	around to Item No. 2.
4	Okay. Staff.
5	MS. WATTS: Melinda Watts for staff.
6	Commissioners, Item 2 is staff's
7	recommendation on the initial water and wastewater
8	rates and charges for South Sumpter Utility, LLC,
9	in Sumter County.
10	The Commission granted the utility's request
11	for an original certificate at its February 7th,
12	2017, Agenda Conference, and waived certain rules
13	requiring the utility to file information necessary
14	for setting rates until later in the year.
15	Staff recommends that the Commission should
16	approve the recommended rates and charges.
17	Yesterday afternoon, South Sumter filed a
18	request in the docket file to amend its requested
19	wastewater service availability charges.
20	Mr. Marty Friedman and Mr. Tray Arnett are
21	here on behalf of the utility to address its
22	request and to answer questions.
23	Staff is also available to answer questions.
24	CHAIRMAN GRAHAM: Thank you, staff.
25	Mr. Friedman.

1 MR. FRIEDMAN: Thank you, Mr. Chairman, Commissioners, Marty Friedman of Friedman & 2 3 Friedman on behalf of the applicant. 4 As she mentioned, we -- we are okay with the 5 staff recommendation. The only -- only request 6 that we had made of staff was that on Issue 10, 7 that the main extension charge be changed to 8 eighteen-zero-one and that the plant capacity 9 charge be changed to \$450, with no change in the 10 rates, though, however. 11 And we have discussed that with staff, and 12 it's my understanding that staff does not have any 13 objection to that request. Otherwise, Mr. Arnett 14 and I are here to answer any questions that you may 15 have. 16 Thank you. 17 CHAIRMAN GRAHAM: Thank you, Mr. Friedman. 18 Commissioners, any questions of staff or of 19 the applicant? 20 Seeing none, I will entertain a motion. 21 COMMISSIONER POLMANN: I will move staff 22 recommendation on all issues, Mr. Chairman. 23 CHAIRMAN GRAHAM: With the inclusion of the 24 change in Issue No. 10? 25 COMMISSIONER POLMANN: The utility has

1	represented a decrease in their request, and I
2	talked with staff about that. Since they don't
3	have an issue with that, I am not going to go into
4	detail on that. I would include the utility's
5	request, so, yes, sir.
6	CHAIRMAN GRAHAM: All right. That's been
7	moved and seconded.
