NOTICE is hereby given that the Florida Public Service Commission, pursuant to Section 120.54, Florida Statutes, has proposed the amendment of Rule 25-4.004, F.A.C., Certificates of Necessity or Authority; Application, and the repeal of Rule 25-4.005, F.A.C., Transfer of Certificate of Necessity or Authority, to modify, streamline and clarify the application form, assist in avoiding applicant confusion, and eliminate redundancy in the rules.
