2 CHAIRMAN GRAHAM: Item 2 and 3, we'll come
3 back to.

4 Item No. 4.

5 MR. BARRETT: Good morning, Commissioners.
6 I'm Michael Barrett with staff.

7 Item 4 is a petition from Florida Power &
8 Light Company addressing the transfer of a pipeline
9 lateral and to implement the associated billing
10 adjustments effective with the first billing cycle
11 of September.

12 The conceptual framework for transferring the
13 Martin to Riviera pipeline lateral from FPL to
14 Florida Southeast Connection, LLC, was introduced
15 in FPL's rate-case proceeding in 2016. And the
16 case was resolved by the comprehensive settlement
17 order cited in staff recommendation.

18 If approved, the requested adjustment will
19 lower base-rate charges and elevate fuel cost
20 recovery charges by modest amounts. The bill for a
21 residential customer using 1,000-kilowatt hours of
22 electricity will be two cents lower per month,
23 beginning in September.

24 Staff is not aware of any customer comments
25 that have been filed in this docket, and we

1 recommend approval of Item 4.

2 CHAIRMAN GRAHAM: Thank you, staff.

3 Mr. Barrett, who is that sitting next to you?
4 I'm not quite sure. I don't see her -- her name
5 card in front of you.

6 MR. BARRETT: Mr. Chairman, I made absolutely
7 sure that I had my name tag today.

8 CHAIRMAN GRAHAM: Mr. Fay, do you know who
9 that is sitting next to her?

10 COMMISSIONER FAY: Mr. Chairman, I believe
11 that's an un-opinionated lawyer.

12 COMMISSIONER POLMANN: I've never heard of
13 such a thing.

14 (Laughter.)

15 CHAIRMAN GRAHAM: Does it even exist?

16 Okay. Commissioners, any questions of staff?
17 Commissioner Brown.

18 COMMISSIONER BROWN: Mr. Chairman, I would
19 move the staff recommendation on all issues on
20 Item 4.

21 COMMISSIONER POLMANN: Second.

22 CHAIRMAN GRAHAM: It's been moved and second,
23 staff recommendation on all issues on Item 4. Any
24 further discussion?

25 Seeing none, all in favor, say aye.

1 (Chorus of ayes.)

2 CHAIRMAN GRAHAM: Any opposed?

3 By your action, you have approved staff
4 recommendation.

5 Thank you, Mr. Barrett and whoever that is
6 next to you -- Ms. Murphy.
