Dear Mr. Rosner:

As we discussed on January 11, 2013, this letter responds to your January 10, 2013, letter on the proposed amendment of Chapter 25-24, Florida Administrative Code.

**24-24.511(2): PSC/TEL 32**

You noted that the Commission's rule number should be inserted into the form. We agree and have added that.

**Page 3, numbers 8-11 and 13**

You note that registration numbers are not contained in the document. This is intentional, and the applicant will fill in those numbers. We have added blank lines to indicate these are for the applicant to complete.

**Page 7: Regulatory Assessment Fee**

You ask that we identify on the form the agency rules which specify the amount of the fees. We will add that to the form. It is Rule 24-4.0161(b) Regulatory Assessment Fees; Telecommunications Companies.

**25-24.512(2)**

You note that although the rule contains the effective date of form PSC/TEL32, it is not so referenced in the previous rule or on the document itself. We are adding this to Rule 25-24.511, F.A.C., and to the form itself.

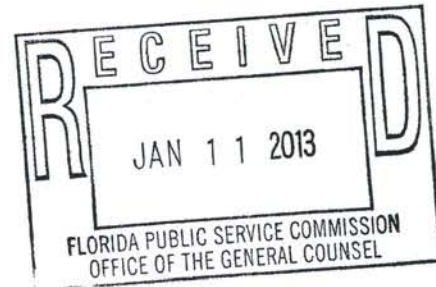

I have completed a review of the proposed amendment of chapter 25-24, FAC, and prepared the following comments for your consideration and response.

**25-24.511(2): PSC/TEL 32**

Although the bottom of the form contains a reference to the commission's rule number, no rule is provided. The number should be inserted into the form.

**Page 3, numbers 8-11 and 13**

Although these subsections reference various registration numbers, they are not contained in the document. Is this intentional?

**Page 7: Regulatory Assessment Fee**

Although the form refers to a "regulatory assessment fee" as well as a "minimum annual assessment fee" no such fees are set forth. Please identify the department rules which specify the amount of such fees.


**25-24.512(2)**
