**Re: Request to Cancel Registration of Tower Cloud, Inc. (Company Code TK075)**

Dear Ms. Stauffer:

On behalf of Southern Light, LLC ("Southern Light"), as the successor in interest to Tower Cloud, Inc. ("Tower Cloud"), this letter notifies the Commission that on June 30, 2018, Tower Cloud merged with and into Southern Light, with Southern Light surviving ("Transaction"). The Transaction was undertaken in order to consolidate and streamline operations among several businesses owned by Uniti Group Inc. into a single unified and rebranded operating entity: Southern Light. As a result, Tower Cloud no longer exists and Southern Light provides telecommunications services to Tower Cloud's customers pursuant to Southern Light's Certificates.<sup>1</sup>

Southern Light respectfully requests that the Commission cancel Tower Cloud's registration, effective immediately or as soon as the Commission can take such action. Tower Cloud is registered to provide intrastate interexchange telecommunications services pursuant to Docket No. 2006-0403. To the extent that Tower Cloud has any tariffs on file with Commission, Tower Cloud requests that such tariffs be cancelled and withdrawn.

Tower Cloud provided services to its customers through contract arrangements. The parties informed customers of the change pursuant to their contractual notification requirements. Moreover, because Southern Light acquired all of the assets of Tower Cloud necessary to provide service to the transferred customers, Southern Light has all of the assets required to continue to provide high-quality services to the customers it acquired. And, Southern Light's operations
