This was done in-house under the Operations and Maintenance Agreement with U.S. Water Service Corporation. This was a relatively small job.

No additional bids were sought from other contractors due to the nature of the work and the location of the utility in a rural area of Florida. It is not always possible to obtain three bids, or even two bids on most projects.

Many outside contractors have became more reluctant to continue to provide bids and quotes – while knowing that they will not be awarded the job. Many outside contractors have become aware that the solicitation of additional bids are more for the FPSC review and they are not willing to take time and effort in providing additional bids since they are more aware that they will not be awarded the job.
