JOINT MOTION TO CONTINUE HEARING

- 1. The parties have entered into a Settlement Agreement, subject to the approval of the Clermont City Council) which will result in the withdrawal of the CITY's Objection to the Application for Transfer of Assets of Exempt Utility and for Amendment of Certificate 465-S, and moot the necessity of moving forward with the formal hearing requested therein.
- 2. It was anticipated that the Clermont City Council would approve the Settlement Agreement at its August 28, 2018, Council meeting, however, due to a procedural glitch this matter did not make the Agenda for that meeting. The City Council's consideration of the Settlement Agreement is now scheduled for the September 11, 2018 City Council Meeting.
