Subject: Proposed Rule Development – Request for Workshop


Dear Ms. Cibula:

BellSouth Telecommunications, Inc. has reviewed the Notice of Proposed Rule Development (Rules 25-4.110, 25-24.490, 25-24.585, and 25-24.845, F.A.C.) that was issued by the Florida Public Service Commission on December 11, 2002. After reviewing the proposed rule changes, BellSouth requests that a rule development workshop be scheduled.

Of specific concern to BellSouth is the use of the words “describe each” on page 4, section 25-4.110(2)(d)2.a. instead of the current word “identify” as it applies to Florida taxes and fees shown on the customer’s bill. We are unsure as to exactly what change is envisioned by the Commission Staff and what would be acceptable as a “description” on the bill.
