St. Joe Natural Gas Company, Inc. ("SJNG") by and through its undersigned officer, hereby submits its Prehearing Statements for the hearing scheduled to commence in the proceeding **November 5, 2018**.

A. Witness that may be called:

C. Statement of Basic Position:

The Commission should approve the final adjusted net true-up amount for the twelve- month period ending December 31, **2018** including interest, the projected conservation program expenses for the twelve-month period ending Dec 31, **2019** and the Conservation Cost Recovery Factors to be applied to customer bills rendered for the twelve-month period ending December 31, **2019** as filed by SJNG.

D. SJNG's position on each issue:

Issue 1. What are the final conservation cost recovery adjustment true-up amounts for the period January **2017** through December **2017**?

SJNG: An under-recovery of **\$2,059**.

Issue 2. What are the appropriate conservation adjustment actual/estimated true-up amounts for the period January through December **2018**?

SJNG: Conservation adjustment actual/estimated true-up is **\$10,204 under-recovery**.

Issue 3. What are the appropriate total conservation adjustment true-up amounts to be collected/refunded from January through December **2019**?

SJNG: The total conservation adjustment true-up amount to be collected is **\$12,263 under-recovery**.

Issue 4. What are the final conservation cost recovery adjustment true-up amounts to be collected during the January through December **2019** period.

SJNG: The true-up amount to be collected is **\$171,413 under-recovery**.

Issue 5. What are the conservation cost recovery factors for the period January **2019** through December **2019**?

SJNG: The appropriate factors are:

RATE CLASS	RATE/\$PER THERM
RS-1	\$0.43076
RS-2	\$0.26408
RS-3	\$0.19925
GS-1	\$0.17245
GS-2	\$0.07667
GS-4/TS-4	\$0.03544

Issue 6. Should the Commission approve revised tariffs reflecting the natural gas conservation cost recovery amounts and establishing natural gas conservation cost recovery factors determined to be appropriate in this proceeding?

SJNG: Yes. The Commission should approve revised tariffs reflecting the new Conservation Cost Recovery charges determined to be appropriate in the proceeding.

Issue 7. What should be the effective date of the new conservation cost recovery factors for billing purposes?

SJNG: The effective date should be January 1, **2019**.
