Pursuant to Rule 25-6.078(3), F.A.C., enclosed please find FPL's Form PSC/EAG 13, Exhibit 1, reflecting the updated Overhead vs. Underground Charge Differential for a Low Density 210 Residential Lot Subdivision. As reflected on the enclosed Form, the current cost differential is less than 10% from FPL's last approved URD charge for a low density subdivision. However, because it has been three years since FPL updated its URD charge, FPL will be filing an updated written URD policy and supporting data and analyses in 2019 pursuant to the Rule.
