**Provide explanation:** DEF filed a petition for temporary wavier from Rule 25-6.100, F.A.C., on Tuesday Oct. 16, 2018. DEF requested a temporary waiver from the Rule 25-6.100, F.A.C., requirement that DEF render monthly bills to its customers. DEF's customers in Bay, Gulf, Franklin, and Wakulla Counties have sustatined extensive damage from Hurricane Michael, making billing of these customers impossible or impracticable at this time. Staff believes that under the circumstances it is preferable to bring DEF's petition for waiver to the next Agenda Conference.
