STATEMENT TO THE PSC:

My name is James Patrick Hill, better known as Toby Hill. I have been a Vero Beach resident since 1980, Vero Electric customer for both my residence and my construction business, and I am on the board of the Indian River Tea Party. I have been an outspoken supporter of this sale since the discussion began almost 10 years ago, and I have been actively involved in Vero Beach politics for decades.

Hurricane Michael's impact on our State required you to move your meeting regarding the purchase of Vero Beach Electric by FPL. This of course was very appropriate, but made it impossible for me to attend the re-scheduled hearing.

As a member of this community, a ratepayer, and a Tea Party member I have watched the group of folks who oppose the sale of Vero Electric to FPL very closely, some of whom will come before you today. The insinuation that our community didn't desire this sale, that misinformation was spread, and that election manipulation was fostered by advocates of this sale is simply not the case.

The sale of Vero Electric to FPL was the topic of the day for years on end. Many, many City Council meetings, newspaper articles, newsletters, candidate forums were all about the sale. It was the topic of discussion at home, at work, with friends and with political adversaries.

Statement to PSC
