Dear Mr. Smallridge:

Staff reviewed the Utility's response to staff's deficiency letter dated October 24, 2018. After reviewing this information we find the application is still deficient. The remaining deficiencies are identified as:

1. **Notice of Application – Title.** Rule 25-30.030(3)(e), F.A.C., requires that the notice be titled, "Notice of Application for Authority to Transfer Water Certificate of Authorization to Another Regulated Utility." Please amend the notice accordingly.
2. **Notice of Application – Contact Information.** Rule 25-30.030(4)(b), F.A.C., requires that the notice contain the name, address, telephone number, and, if available, email address, and fax number of the applicant. Please amend the notice to include the telephone number, and, if available, email address, and fax number of the applicant.
3. **Notice of Application – Common Names.** Rule 25-30.030(4)(c), F.A.C., requires that the notice include the common name of developments served by the utility. Please amend the notice to include this information
4. **Notice of Application – Docket Number and Title.** Rule 25-30.030(4)(d), F.A.C., requires that the notice include the application docket number and title. Please amend the notice to contain the following information: Docket No. 20180175-WU – Application to transfer facilities and Certificate No. 628-W in Polk County from Alturas Utilities, L.L.C. to Alturas Water, LLC.
5. **Notice of Application – Office of Commission Clerk Address.** Rule 25-30.030(4)(h), F.A.C., requires that the notice include a statement that any objections to the application must be filed with the Office of Commission Clerk, 2540 Shumard Oak Boulevard,

Tallahassee, Florida 32399-0850. Please amend the notice to include the full Office of Commission Clerk zip code of 32399-0850.

6. **Notice of Application – Rates and Charges.** Rule 25-30.030(4)(g), F.A.C., requires that the notice include a statement that the utility is not requesting any changes to its rates, classifications, charges, rules, and regulations in the application. Please amend the notice to include this statement.


7. **Tariff Sheets** - Rule 25-30.037(2)(u), F.A.C., requires that the applicant provide a copy of the tariff sheets reflecting any changes resulting from the transfer. On October 25th the Utility responded to staff's request by providing a copy of a bill statement which is insufficient.

Your application will not be deemed filed until the deficiencies identified in this letter have been corrected. These corrections should be submitted no later than **November 30, 2018**, to the following address:
