FLORIDA POWER & LIGHT COMPANY'S MOTION FOR
TEMPORARY PROTECTIVE ORDER FOR CERTAIN CONFIDENTIAL
INFORMATION PROVIDED IN THE OFFICE OF PUBLIC
COUNSEL'S NOTICE OF DEPOSITION DUCES TECUM OF FLORIDA POWER &
LIGHT COMPANY'S CORPORATE REPRESENTATIVE SCHEDULED FOR
NOVEMBER 15, 2018 AND THE OFFICE OF PUBLIC COUNSEL'S
THIRD REQUEST FOR PRODUCTION OF DOCUMENTS (NO. 19)

Pursuant to section 366.093(3), Florida Statutes, and Rule 25-22.006(6)(c), Florida Administrative Code, Florida Power & Light Company ("FPL"), hereby moves the Florida Public Service Commission (the "Commission"), through the Prehearing Officer, for a temporary protective order to exempt from section 119.07(1), Florida Statutes, certain confidential information included in the Office of Public Counsel's ("OPC") Notice of Deposition Duces Tecum of FPL's Corporate Representative scheduled for November 15, 2018 and FPL's response to OC's Third Request for Production of Documents (No. 19).

- 1. OPC has requested that it be permitted to depose, inspect and/or take possession of FPL's confidential, proprietary information in the Office of Public Counsel's ("OPC") Notice of Deposition Duces Tecum of FPL's Corporate Representative scheduled for November 15, 2018 and FPL's response to OC's Third Request for Production of Documents (No. 19).
- 2. Rule 25-22.006(6)(c), Florida Administrative Code, provides in pertinent part, as follows, with respect to a utility allowing OPC to depose, inspect and/or take possession of the utility's information:
  - a. [T]he utility may request a temporary protective order exempting the information from Section 119.07(1), Florida Statutes. If the information is to be used in a proceeding before the Commission, then the utility must file a specific request for a protective order under paragraph (a) above. If

the information is not to be used in a proceeding before the Commission, the Public Counsel shall return the information to the utility in accordance with the record retention requirements of the Department of State.

- 3. The confidential information includes, but is not limited to: trade secrets; information concerning bids or other contractual data, the disclosure of which would impair the efforts of the company or its affiliates to contract for goods or services on favorable terms; information related to competitive interests, the disclosure of which could harm the competitive business of the provider of the information; and employee personnel information unrelated to compensation, duties, qualifications, or responsibilities (exempt from the Public Records Act pursuant to section 366.093(3)(a),(c),(e),and (f) Florida Statutes).
- 4. FPL respectfully requests that the Commission enter a temporary protective order affording FPL the protection that is needed to provide OPC the confidential information included in this motion for temporary protective order to be produced in the Office of Public Counsel's ("OPC") Notice of Deposition Duces Tecum of FPL's Corporate Representative scheduled for November 15, 2018 and FPL's response to OC's Third Request for Production of Documents (No. 19).
- 5. FPL has been authorized by counsel for OPC to represent that OPC does not object to the granting of this motion but reserves the right to contest the confidentiality of the subject documents.

WHEREFORE, for the foregoing reasons, FPL respectfully requests that the Commission enter a temporary protective order protecting against public disclosure the confidential information contained in the Office of Public Counsel's ("OPC") Notice of Deposition Duces Tecum of FPL's Corporate Representative scheduled for November 15, 2018 and FPL's response to OC's Third Request for Production of Documents (No. 19).
