As noted in Rule 25-6.0426 (3)b, F.A.C. economic development expenses are limited to 95 percent of the expenses incurred for the reporting period so long as such does not exceed the lesser of 0.15 percent of gross annual revenues or \$3 million. As confirmed in the response to Staff's Second Data Request No. 1, the company is limited to a \$3 million absolute cap. However, Tampa Electric acknowledges that in its Petition it did not clearly identify the approximate \$2.9 million as the net recoverable economic development expense amount. The company is limited to eligible recovery of a net \$2.85 million, which represents 95 percent of eligible economic development expenses.
