4 Phillip Ellis, Commission staff.

5 Item 9 before you is the remaining unsettled  
6 issues for the Environmental Cost Recovery Clause,  
7 all of which address Florida Power & Light  
8 Company's programs in recovery.

9 Issues 1 through 4 and 7 address the cost-  
10 recovery factors and the Turkey Point cooling-canal  
11 monitoring plan. Issues 10A and 10B address  
12 modifications to the Manatee temporary heating  
13 system project and the National Pollutant Discharge  
14 Elimination System permit-renewal-requirements  
15 project.

16 Staff rec- -- recommends approval for all the  
17 cost-recovery factors and programs, except for 10B,  
18 as the proposed modifications to the N- -- NPDES  
19 project does not yet have an environmental  
20 requirement.

21 Staff is available for any questions.
