2 CHAIRMAN GRAHAM: Item No. 13 and 14 -- let's  
3 take those up together.

4 MR. MERRYDAY: Good morning, Commissioners.  
5 I'm Henry Merryday with staff.

6 As you said, I'm going to be introducing  
7 Items 13 and 14 together. These are petitions for  
8 approval of tariff modifications by Tampa Electric  
9 Company and Peoples Gas System. The proposed  
10 modifications allowed TECO and Peoples employees to  
11 refuse or discontinue service to customers that  
12 threaten harm to company employees or property.

13 The Commission approved a similar tariff for  
14 Florida Power & Light Company in 1996, and staff  
15 has received no customer comments on these dockets.  
16 Staff believes the proposed tariff modifications  
17 are warranted in order to protect company employees  
18 and property and, therefore, recommends approval of  
19 these petitions.

20 CHAIRMAN GRAHAM: Thank you, staff.

21 Commissioners, any questions of staff for  
22 Item No. 13 or Item No. 14?

23 COMMISSIONER BROWN: Mr. Chairman, I would  
24 move approval of both items, with the staff  
25 recommendation.

1 COMMISSIONER POLMANN: Second.

2 CHAIRMAN GRAHAM: It's been moved and second,  
3 staff rec on Item No. 13 and 14. Any further  
4 discussion?
