ORDER GRANTING TAMPA ELECTRIC COMPANY'S REQUEST FOR  
SPECIFIED CONFIDENTIAL TREATMENT AND MOTION FOR TEMPORARY  
PROTECTIVE ORDER (DOCUMENT NO. 06030-2018, X-REF. 05768-2018)

On September 13, 2018, pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code (F.A.C.), Tampa Electric Company (TECO) filed a Request for Confidential Classification and Motion for Temporary Protective Order (Request) of portions of Audit No. 2018-058-2-2 (Document No. 06030-2018, x-ref. 05768-2018 ).

Request for Confidential Classification

TECO contends that designated portions of the information contained in Audit No. 2018-058-2-2, as more specifically described in the attachment to its Request, constitutes proprietary confidential business information entitled to protection under Section 366.093, F.S., and Rule 25-22.006, F.A.C. The Exhibit attached to TECO's Request contains a detailed matrix providing justification and support for confidential classification of the information in Audit No. 2018-058-2-2 on a line-by-line, column-by-column basis. TECO asserts that this information is intended to be and is treated by TECO as private and has not been publicly disclosed.

Audit No. 2018-058-2-2 contains specific details regarding natural gas hedged volumes or percentages, pricing, and counterparties. TECO states that knowledge of this information would allow the opportunity for market manipulation through transactions made in anticipation of TECO's entry into the market resulting in increased prices for fuel as well as higher hedging costs. For these reasons, TECO concludes that this material falls within the provisions of Sections 366.093(3)(d) and (e), F.S.

Ruling

Section 366.093(1), F.S., provides that the records the Commission has found to contain proprietary confidential business information shall be kept confidential and shall be exempt from Section 119.07(1) F.S. Section 366.093(3), F.S., defines proprietary confidential business information as information that is intended to be and is treated by the company as private, in that disclosure of the information would cause harm to the company's ratepayers or business operations, and has not been voluntarily disclosed to the public. Section 366.093(3), F.S., provides that proprietary confidential business information includes, but is not limited to:

- (d) Information concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms.

- (e) Information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information.

Upon review, it appears that the above-referenced information satisfies the criteria set forth in Section 366.093(3), F.S., for classification as proprietary confidential business information. The information described above appears to be information concerning natural gas hedged volumes or percentages, pricing, and counterparties, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms, and information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information. Thus, the information identified in Document No. 06030-2018, x-ref. 05768-2018, shall be granted confidential classification.

Pursuant to Section 366.093(4), F.S., confidential classification may only extend for up to 18 months from the issuance of an Order granting confidential classification unless “the Commission finds, for good cause, that the protection from disclosure shall be for a specified longer period.” TECO has not requested confidentiality for a period greater than 18 months. Therefore, the information identified in Document No. 06030-2018, x-ref. 05768-2018, shall be granted confidential classification for a period of 18 months from the issuance of this Order.

#### Motion for Temporary Protective Order

TECO also seeks protection of the documents as provided in Section 366.093(2), F.S., and Rule 25-22.006(6), F.A.C. Section 366.093(2), F.S., directs that all records produced pursuant to a discovery request for which proprietary confidential status is requested shall be treated by any party subject to the public records law as confidential and exempt from the public records law. Section 119.07(1), F.S. Rule 25-22.006(6), F.A.C., codifies the Commission’s policy regarding the protection of confidential information from public disclosure during the discovery process in a manner that is not overly burdensome to both parties. Rule 25-22.006(6)(a), F.A.C., in pertinent part, states:

In any formal proceeding before the Commission, any utility or other person may request a protective order protecting proprietary confidential business information from discovery. Upon a showing by a utility or other person and a finding by the Commission that the material is entitled to protection, the Commission shall enter a protective order limiting discovery in the manner provided for in Rule 1.280, Florida Rules of Civil Procedure.

Upon consideration of TECO’s assertions of the confidential nature of the information contained in portions of Audit No. 2018-058-2-2, Document No. 06030-2018, x-ref. 05768-2018, TECO’s Motion for Temporary Protective Order is hereby granted. As a result, this information shall be protected from disclosure pursuant to Rule 25-22.006(6), F.A.C.

Based on the foregoing, it is hereby



ORDERED that Tampa Electric Company's Motion for Temporary Protective Order of the information in Document No. 06030-2018, x-ref. 05768-2018, is granted. It is further

ORDERED that the information in Document No. 06030-2018, x-ref. 05768-2018, for which confidential classification is granted, shall remain protected from disclosure for a period of 18 months from the date of issuance of this Order. It is further

ORDERED that this Order will be the only notification by the Commission to the parties concerning the expiration of the confidentiality time period.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code; or (2) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Office of Commission Clerk, in the form prescribed by Rule 25-22.0376, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
