1	PROCEEDINGS
2	CHAIRMAN GRAHAM: Okay. Staff, Item No. 2.
3	MS. HARPER: Good morning, Commissioners, I'm
4	Adria Harper with the General Counsel's Office.
5	In Item 2, staff is recommending that the
6	Commission amend the rule that requires electric
7	and gas utilities to report certain costs and
8	revenues associated with each utility's
9	conservation program.
10	This is the Commission's only cost recovery
11	rule that currently includes a fixed timeline for
12	actual and estimated filings and a requirement for
13	ECCR proceedings to occur in November of each
14	calendar year. The filing deadlines and hearing
15	schedule associated with all the other annual cost
16	recovery clauses are dictated by each respective
17	clause's OEP.
18	So staff is recommending that the rule be
19	amended to remove the November proceeding
20	requirement in the eight months actual and
21	four-month estimated filing provisions to allow the
22	Commission greater flexibility in scheduling the
23	annual ECCR hearing. These changes to the rule
24	would also likely eliminate the frequent request
25	for rule waivers filed by the utilities resulting

1	from the rule's currently overly restrictive
2	deadlines.
3	Staff is also recommending that the rule
4	remove recommending that the rule remove the
5	requirement for the utilities to complete a short
6	form, which will no longer be necessary since the
7	utilities will provide the actual and estimated
8	filings as required by the OEP.
9	And finally, staff is recommending that the
10	rule be amended to clarify the evaluation of
11	advertising costs associated with conservation
12	efforts. This amendment will clarify that the
13	electric and natural gas conservation programs are
14	approved by Commission order.
15	Staff is available if you have any questions.
16	CHAIRMAN GRAHAM: Thank you, staff.
17	Commissioners, any questions of the staff?
18	Commissioner Polmann.
19	COMMISSIONER POLMANN: Thank you, Mr.
20	Chairman.
21	I believe the recommendation does make this
22	more efficient for us, and I don't see any downside
