4	Doug Wright with commission staff. Item No. 7 is a
5	petition by Duke Energy Florida, LLC, to adjust the
6	delivery voltage adjustment factors found in Duke's
7	standard offer contract. On October 31st, 2018,
8	Duke filed with the Federal Energy Regulatory
9	Commission a settlement agreement that alters
10	Duke's delivery voltage adjustment factors
11	beginning January 1st, 2019. On January 28th, 2019
12	the FERC issued Letter Order 166 FERC 61,057,
13	approving the settlement agreement.
14	This approval necessitates adjustment of two
15	of the three delivery voltage adjustment factors
16	found in Duke's standard offer contract. Duke has
17	provided a revised tariff sheet reflecting the
18	necessary adjustments. Staff has reviewed these
19	updated values and recommends approval of Duke's
20	petition.
