Currently the rates and charges for Waste Water Service are regulated by the Florida Public Service Commission.

The Board of Directors has become aware that P.I.C.H.A. should be exempt from the Commission's jurisdiction pursuant to Section 367.022(7) of Florida Statutes and is requesting that the Public Service Commission cancel Certificate No. 453-S.

The cancellation of the certificate will reduce the reporting requirements associated with plant operations and reduce costs. Plant operations will still be regulated by the Florida Department of Environmental Protection and P.I.C.H.A. will continue to comply with all regulations in order to maintain effective and safe operations.

The Commission will consider the request at the April 2, 2019 Agenda Conference. Docket # 20180232-SU.
