**DUKE ENERGY FLORIDA LLC'S NOTICE OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION**

Duke Energy Florida, LLC ("DEF" or "Company"), pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code (F.A.C.), submits this Notice of Intent to Request for Confidential Classification of confidential portions of DEF's response to OPC's Ninth Set of Interrogatories (Nos. 132-143). Specifically, the interrogatory questions and responses relating to questions 132, 133, 134, and 135 contain confidential business information relating to vendor contract terms and contractual vendor costs. The disclosure of this confidential information to the public would adversely impact DEF's competitive business interests and would impair DEF's ability to contract for goods and services on favorable terms.

Under a separate cover letter, DEF has filed confidential Exhibit A concerning the above-referenced confidential documents.

Pursuant to Rule 25-22.006(3)(a)1, DEF will file its Request for Confidential Classification for the confidential information contained herein within twenty-one (21) days of filing this request.
