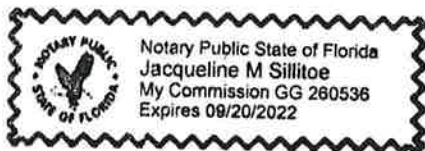

On August 9, 2017 Utilities, Inc. of Florida (UIF or Utility) filed an application for transfer of the Barrington Estates wastewater system in Lake County to UIF.

Notice is hereby given by Order No. PSC-2019-0071-PAA-SU issued February 25, 2019, in Docket No. 20170174-SU, the Commission approved the transfer of the wastewater system to UIF.

It is important to note that your rates have changed in the transfer. Attached is a comparison of the previous rates and UIF's current rates. Additionally, a schedule showing Initial Customer Deposits and Miscellaneous Service Charges is included.

The approved rates and charges shall be effective for the Barrington Estates for service rendered the sale of the System is final which is anticipated to be April 1, 2019. If the effective date of the new rates falls within a regular billing cycle, the initial bills at the new rate may be prorated. The new charges shall be prorated based on the number of days in the billing cycle on or after the effective date of the new rates.
