Dear Mr. Fonder:

Commission staff has reviewed A Utility Inc.'s affidavit of mailing the notice of transfer of the Tropical Park water system to its customers and to the appropriate government entities and utilities. After reviewing this information we find the application to be deficient. The specific deficiencies are identified as:

1. **Proof of Noticing.** Rule 25-30.030(6), Florida Administrative Code (F.A.C.), requires that an affidavit of noticing along with a copy of the notice are to be provided to the Office of Commission Clerk. A copy of the notice mailed to the utility's customers and to the appropriate government entities and utilities was not attached to the affidavit. Please provide a copy of the notice mailed to the customers.
2. **Proof of Noticing.** Rule 25-30.030(6), F.A.C., also requires that the applicant obtain an affidavit of notice publication, pursuant to Rule 25-30.030(5)(c), F.A.C., from the newspaper(s) to be provided to the Office of Commission Clerk. Please provide a copy of the affidavit of notice publication from the newspaper(s) that published the notice.

Your application will not be deemed filed until the deficiencies identified in this letter have been corrected. These corrections should be submitted no later than May 17, 2019, to the following address:
