I have reviewed the above-referenced rule and offer the following comment for your consideration and response:

**25-12.005:** The purpose and effect portion of the proposed rule notice indicates that the Commission is updating this rule to incorporate the 2018 version of the referenced material; however, the proposed rule text indicates a version date of 2019, with a copy of the unofficial eCFR version of the material provided. Currently, the most up to date officially codified version of title 49 of the Code of Federal Regulations features a revised date of October 1, 2018. Please review and revise for consistency with the official version of the Code of Federal Regulations. If amendments to certain regulations contained within the referenced title have subsequently been enacted since the last official version, these amendments should be incorporated in their official format (i.e. through the Federal Register). Additionally, please provide updated copies of the materials to reflect those incorporated by reference.
