Dear Ms. Stauffer:

Fusion, LLC d/b/a Fusion Connect, LLC (“FCL”), Fusion Cloud Services, LLC (“FCS”) and Cbeyond Communications, LLC (“Cbeyond”)¹ (together, the “Fusion Fla. Companies”) respectfully submit this letter to notify the Florida Public Service Commission (the “Commission”) that on June 3, 2019, their parent company, Fusion Connect, Inc. and all of its U.S. subsidiaries, including the Fusion Fla. Companies (collectively, “Fusion”), filed for protection under Chapter 11 of the Bankruptcy Code in the United States Bankruptcy Court for the Southern District of New York (the “Petition”).²

Fusion filed for Chapter 11 protection in order to restructure its capital structure. Following completion of the proposed restructuring, Fusion expects to emerge financially stronger. **Importantly, the filing of the Petition does not reflect, or result in, any immediate changes to Fusion’s current operations. The Fusion Fla. Companies continue to serve their customers on an uninterrupted basis and the Chapter 11 filing does not in any way alter**
