(2) The Utility has added a general service customer with an 8” turbine meter. This is not a new class of service, but merely a calculation of an 8” turbine meter bfc based up the meter equivalency factors in Rule 25-30.055, Florida Administrative Code. Based upon the recent index increase and the application of that Rule, the water bfc is calculated at \$2,509.20 and the wastewater bfc is calculated at \$2,784.60.

(3) WHEREFORE, PLURIS WEDGEFIELD, LLC, requests that the Commission approve the attached water and wastewater Tariff Sheets implementation of the 8” general service base facility charge as requested above.
