2 CHAIRMAN GRAHAM: Okay. Let's get started.

3 Let the record show it is June 11th and this is our
4 agenda conference. And the agenda today, we're
5 going to come back to Item No. 1. We'll come back
6 to Item No. 2. Item No. 3 is on move staff. Item
7 No. 4, we'll take up very last. Item 5, 6 and 7
8 are on move staff. So, staff, let's start off with
9 Item No. 3.

10 MS. HARPER: Good morning, Commissioners. I'm
11 Adria Harper with the General Counsel's Office. In
12 Item 3, staff is proposing the adoption of a new
13 rule, Rule 25-22.108, for change of regulated
14 utility information, which would simply codify the
15 Commission's current practice of requiring each
16 utility to submit its contact information to us
17 within 30 days if they have any changes.

18 Staff is also recommending repealing rules
19 25-4.0051 and 25-4.520, which are limited to
20 telecommunications and pay telephone service
21 companies only. Staff believes that these rules
22 are necessary and should be repealed and replaced
23 by the new rule that we're recommending, which is
24 25-22.108, and will cover all utilities.

25 CHAIRMAN GRAHAM: Thank you, staff.

1 Commissioners, any questions of staff for item No.
2 3?

3 COMMISSIONER BROWN: Move staff recommendation
4 as determined.

5 COMMISSIONER POLMANN: Second.

6 CHAIRMAN GRAHAM: It's been moved and
7 seconded, staff recommendation on Item No. 3. Is
8 there any further discussion?

9 (No comments made.)

10 CHAIRMAN GRAHAM: Seeing none, all those in
11 favor say, aye.
