1 PROCEEDINGS 2 CHAIRMAN GRAHAM: On to Item No. 3. 3 MR. RICHARDS: Good morning, Mr. Chairman, 4 Commissioners. My name is Chris Richards with 5 Commission staff. Item No. 3 addresses a petition by Peoples Gas 6 7 System in Docket No. 20190091-GU for authority to 8 accrue an allowance for funds used during 9 construction. 10 Staff believes the company's request is 11 reasonable and in accordance with Rule 25-7.0141 of 12 the Florida Administrative Code and, therefore, 13 recommends that the Commission authorize Peoples 14 Gas to accrue AFUDC at an annual rate of 5.97 15 percent. 16 Staff is available to answer any questions. 17 CHAIRMAN GRAHAM: Thank you, staff. 18 Commissioners, any questions of staff? 19 Commissioner Brown. 20 COMMISSIONER BROWN: Thank you. 21 And I agree that the request does appear to be 22 reasonable. Why do we not have a rule, though, 23 regarding AFUDC for the natural gas companies? 24 MR. RICHARDS: Ma'am, looking back, it 25 appears, back around 1995, no gas companies had

1 come in for AFUDC for such a long time that it was 2 decided to just go ahead and kind of do away with 3 the rule. And no companies have come in, you know, 4 for the past, what, 24 years until just now. 5 So it's just it hasn't been used, and I believe they were trying to kind of do away with 6 7 unused rules, or rarely used rules, back at that 8 time, and it appeared that, for gas utilities, 9 AFUDC, it wasn't an issue. 10 COMMISSIONER BROWN: And I understand your 11 recommendation does appear to be reasonable. So it 12 would yous suggest that this would be a ripe time, 13 given the circumstances, to at least not initiate 14 rule-making but looking into it. 15 MR. RICHARDS: Yes, ma'am. I agree. 16 It's certainly up for MR. SCHRADER: 17 discussion, yeah. 18 I mean, just based on the COMMISSIONER BROWN: 19 recommendation, it looks like it would be ripe for 20 discussion, at least, purposes moving forward. 21 So, Mr. Chairman, I would suggest that staff 22 look into it, and I would recommend approving the 23 recommendation. 24 CHAIRMAN GRAHAM: Is that a motion? 25 COMMISSIONER BROWN: Move, yeah.
