6	name is Clayton Lewis, and I am introducing Items 9
7	and 10 on behalf of Commission staff.
8	These items are staff's recommendations for
9	approval for the transfer of Sunrise Utilities,
10	LLC, and Alturas Utilities, LLC, to Sunrise Water,
11	LLC and Alturas Water, LLC, respectively.
12	Sunrise's certificate No. 627-W, and Alturas
13	certificate number is 628-W. Both water systems
14	are located in Polk County, and both were purchased
15	by the same buyer.
16	There have been no customer comments filed in
17	these dockets supporting or opposing the transfers.
18	Staff is available to answer your concerns.
19	COMMISSIONER GRAHAM: Thank you, staff.
20	Commissioners, any questions of staff for
21	Items 9 or 10?
22	Commissioner Polmann.
23	COMMISSIONER POLMANN: Thank you, Mr.
24	Chairman.
25	I understand there were some improvements that

1	were needed. Can you clarify within the
2	system can you clear clarify or may make a
3	comment on the status? Are we aware of some system
4	improvements?
5	MR. LEWIS: Yes, sir. The two utilities were
6	under consent orders from the health department,
7	DEP, and that was discussed in the SARC.
8	At this particular time, our understanding is
9	that the new owner has made a significant amount of
10	the repairs, but however, DEP is requiring that a
11	professional engineer inspect it before they will
12	sign off on it, and as of this date, we have not
13	received confirmation of DEP's satisfaction with
14	the repair work that has been done to date.
15	COMMISSIONER POLMANN: Okay. So those issues
16	are not part of this proceeding here today, is that
17	correct?
18	MR. LEWIS: That's correct. It's not part of
19	the proceeding today.
20	COMMISSIONER POLMANN: Okay. Very good.
21	Thank you for the clarification.
22	Mr. Chairman, if there is no other questions I
23	move approval of staff recommendation on all issues
24	on Items 9 and 10.
