Duke Energy Florida, LLC (“DEF” or the “Company”), pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code (F.A.C.), submits this Notice of Intent to Request Confidential Classification of documents provided in DEF’s Corrected Response to Office of Public Counsel’s (“Citizens” or “OPC”) Third Set of Interrogatories (Nos. 16-17) filed contemporaneously with this notice. Confidential documents have been filed with the clerk and the redacted versions have been filed as part of DEF’s Corrected Response to OPC’s Third Set of Interrogatories. Specifically, the documents provided in question 16, contain confidential business information related to future plans for generation work, cost estimates for outage scope, and bid evaluations which includes proprietary information of third parties. The disclosure of that information to the public would adversely impact DEF’s competitive business interests.
