On July 22, 2019 SeaCoast Gas Transmission, LLC (SeaCoast) filed a request for confidential classification for Document No. 05919-2019. This document contains information in Exhibits A and B to its firm service agreement (which is Exhibit C to the joint petition) with Peoples Gas System (PGS). The confidential information is related to maximum daily transportation quantity and the reservation charge. Staff reviewed the document and concurs with SeaCoast that the nature of the information meets the requirements set forth in Sections 366.093(3)(d) and (e), Florida Statutes, whereby disclosure of the information would harm the competitive business operations of both SeaCoast and PGS.

Therefore, staff recommends that the request by SeaCoast for confidential classification of Document No. 05919-2019 be approved.
