Dear Mr. Friedman:

By this letter, the Commission staff requests that CHC VII, Ltd. (CHC or utility) provide responses to the following data requests.

1. Please describe any potential impacts the new AMR meters could have on the system, including impacts on excessive unaccounted for water, compared to the existing meters.
2. Please answer the following questions regarding the requested rate case expense reflected in Schedule No. 12 of the utility's application for a limited proceeding rate case:
 - a. For each individual person, in each firm providing consulting services to the applicant pertaining to this docket, provide the billing rate, and an itemized description of work performed. Please provide details of the hours worked associated with each activity. Also, provide descriptions and associated costs for all expenses incurred to date.
 - b. For each firm or consultant providing services for the applicant in this docket, please provide copies of all invoices for services provided to date.
 - i. If consultant invoices are not broken down by hour, please provide reports that detail by hour, a description of actual duties performed, and amount incurred to date.
 - c. Please provide an estimate of costs to complete the case by hour for each consultant or employee, including a description of estimated work to be performed, and detail of the estimated remaining expense to be incurred through the Proposed Agency Action (PAA) process.
 - d. Please provide an itemized list of all other costs estimated to be incurred through the PAA process.
