2	CHAIRMAN GRAHAM: Okay. We're coming back to
3	4. So the next item is Item No. 5.
4	MS. KNOBLAUCH: Emily Knoblauch for staff.
5	Item 5 is staff's recommendation addressing the
6	application for a staff-assisted rate case by TKCB,
7	Inc. TKCB is a Class-C utility providing wastewater
8	service to approximately 274 customers in Brevard
9	County. Based on a review of the utility's data
10	for the test year, staff is recommending an
11	increase in the revenue requirement of 13.20
12	percent or \$11,044 annually. A customer meeting
13	was held in May of this year and no customers
14	attended the meeting. Additionally, there have
15	been no customer comments filed in the docket.
16	Jeff Small is here on behalf of the utility and
17	staff is available for any questions.
18	CHAIRMAN GRAHAM: Thank you, staff.
19	Commissioners, any questions of staff?
20	Commissioner Brown.
21	COMMISSIONER BROWN: Thank you. In issue six,
22	you reference an Atlantis Investments, which you
23	state is a related party. Can you state what the
24	nature of that business is? I understand that they
25	share rental space very closely tied to the

1	utility.
2	MR. SEWARDS: Yeah, the Atlantis Investments
3	is owned by the same as the president of TKCB is
4	also the owner of Atlantis Investments. Beyond
5	it's beyond being an investment company, we
6	didn't really delve too far into the details of it.
7	COMMISSIONER BROWN: Are the officers and
8	directors and employees the same of the utility in
9	Atlantis Investments?
10	MR. SEWARDS: Yes, there is just the one
11	president and one employee.
12	COMMISSIONER BROWN: Does anybody know what
13	the nature of the business is, since they share
14	space and employees? I see someone coming up.
15	Maybe.
16	MR. SMALL: Good morning, Commissioners. Jeff
17	Small, OCBOA Consulting, LLC on behalf of TKCB.
18	Atlantis Investments is a mobile home rental sales
19	investment-type community. The mobile home park
20	that is in the service territory of the utility was
21	at one time owned by Thad Terry, the president.
22	And it was a partnership of four individuals and he
23	is the only surviving individual, so he has the
24	sewer plant and he also he sold off the mobile
25	home park and he provides wastewater service to

1	that customers, but he also owns lots in there. He
2	rents out lots. He rents out mobile homes and he
3	also sells mobile homes, but not exclusively to
4	that park.
5	COMMISSIONER BROWN: Okay. Thank you.
6	If there are no other questions by the
7	Commissioners, I'd move approval of all issues in
8	this item.
9	COMMISSIONER POLMANN: Second.
10	CHAIRMAN GRAHAM: It's been moved and
11	seconded, approval of all issues on Item No. 5.
12	Any further discussion?
13	(No comments made.)
14	CHAIRMAN GRAHAM: Seeing none, all in favor
15	say, aye.
