3 MS. GUFFEY: Item 10 is also petition from
4 Peninsula Pipeline Company requesting Commission
5 approval of a 20-year firm gas transportation
6 service agreement with Florida Division of
7 Chesapeake Utilities Corporation, doing business as
8 Central Florida Gas. The negotiated agreement
9 requires Peninsula to acquire or construct
10 approximately 15,000 feet of gas transportation
11 pipelines in Polk County. The negotiated monthly
12 reservation charge Central Florida Gas will pay
13 Peninsula is designed to recover Peninsula's cost
14 of service and will be recovered through its swing
15 service rider mechanism. Staff is not aware of any
16 customers complaints or correspondence regarding
17 this docket. Staff recommends approval of
18 Peninsula's petition and is available to answer
19 questions.
