1	PROCEEDINGS
2	CHAIRMAN GRAHAM: Next is Item No. 11.
3	MR. GRAVES: Good morning, Commissioners,
4	Robert Graves with staff. Item 11 addresses FIMC's
5	compliance with Commission Order 2019-0074-PAA-WS.
6	In that order, the Commission recognized that the
7	utility was not meeting certain DEP secondary water
8	standards and ordered FIMC to create a cost
9	assessment for a plausible solution and to meet
10	with its customers to present that solution. At
11	the meeting with the utility's customers, four
12	solutions were presented. By a show of hands, the
13	customers were in favor of accepting the current
14	water quality and doing something at their homes.
15	Staff recommends that the utility has complied with
16	the Commission's order and that no additional
17	action is necessary at this time with respect to
18	the utility's water quality. Staff's available if
19	you have any questions.
20	CHAIRMAN GRAHAM: Thank you, Staff.
21	Commissioners, any questions of staff on Item
22	No. 11? Commissioner Polmann.
23	COMMISSIONER POLMANN: Thank you Mr. Chairman.
24	Mr. Graves, I want to highlight a portion of your
25	comment at this time. It there a follow-up that we

1	anticipate? Is there some kind of monitoring that
2	staff would be doing going forward, or is this
3	closing out the item?
4	MR. GRAVES: It would be closing out the item,
5	is more in reference to this particular SARC. If
6	the utility came back, obviously we would take
7	another review of the quality of service.
8	COMMISSIONER POLMANN: So this arose as a
9	result of a DEP finding or a routine review, or is
10	that periodic on a certain time frame, certain
11	number of years in terms of their review of water
12	quality?
13	MR. GRAVES: Yes, sir. They review secondary
14	water standards every three years. The last one
15	occurred towards the end of 2018, but really this
16	arose through the utility's rate case before the
17	Commission and then our review of the compliance
18	with DEP.
19	COMMISSIONER POLMANN: What I'd like to know
20	is if this closes our action here today would
21	close this particular item, what would be the next
22	logical opportunity in the normal course of
23	business for this to be reviewed again? Is that
24	something you can answer or is that it will come
25	up, when it comes up, I guess is my question.

1	MR. GRAVES: Yes, sir, and I think that would
2	be subject to the utility coming before the
3	Commission again.
4	COMMISSIONER POLMANN: Okay. Well, thank you
5	very much.
6	CHAIRMAN GRAHAM: Any further questions?
7	(No comments made.)
8	CHAIRMAN GRAHAM: I'll entertain a motion.
9	COMMISSIONER CLARK: Move staff on all items,
10	Mr. Chairman.
11	CHAIRMAN GRAHAM: It's been moved and
12	seconded, staff recommendation on all issues on
13	Item No. 11. Any further discussion?
14	(No comments made.)
15	CHAIRMAN GRAHAM: Seeing none, all in favor
16	say, aye.
