4	speaking on behalf of Commission staff. Item No.
5	12 addresses Pluris Wedgefield, LLC's application
6	for approval of an eight-inch general service meter
7	rate. The utility's a Class-A utility providing
8	water service to 1,811 customers and wastewater
9	service to 1,667 customers in Orange County. The
10	utility's existing water and wastewater general
11	service tariff sheets only provide a base facility
12	charge for meters up to sizes to six inches. This
13	recommendation addresses the utility's request to
14	revise its water and wastewater tariffs to include
15	a BFC for an eight-inch turbine meter rate. The
16	requested BFC for an eight-inch meter size is
17	consistent with the American Water Works
18	Association meter equivalence. And, as a result,
19	staff recommends approval. There's been no staff
20	contact. Staff is prepared to answer any questions
21	at this time.
