**ST. JOE NATURAL GAS COMPANY'S PRELIMINARY
LIST OF ISSUES AND POSITIONS**

St. Joe Natural Gas Company, Inc. ("SJNG") by and through its undersigned officer, hereby submits its Preliminary List of Issues and Positions to be taken up at the Hearing now scheduled to begin **November 5, 2019** in the above listed docket.

Issue 1: What are the final conservation cost recovery adjustment true-up amounts for the period January through December **2018**?

SJNG's Position: \$33,880 under-recovery.

Issue 2: What are the appropriate conservation adjustment actual/estimated true-up amount for the period January through December **2019**?

SJNG's Position: \$129,574 under-recovery

Issue 3: What are the appropriate total conservation adjustment true-up amount to be collected/refunded from January **2020** through December **2020**?

SJNG'S Position: \$163,454 under-recovery

Issue 4: What is the total conservation cost recovery amounts to be collected during the period **January 2020** through **December 2020**?

SJNG's Position: An Under-recovery of \$325,579.

Issue 5: What are the conservation cost recovery factors for the period January **2020** through December **2020**?

SJNG's Position: \$0.77770 per therm for RS-1, \$0.46887 per therm for RS-2, \$.35818 per therm for RS-3, \$.30848 per therm for GS-1, \$.14838 per therm for GS-2, and \$.07855 per therm for FTS-4.

Issue 6: Should the Commission approve revised tariffs reflecting the natural gas conservation cost recovery amounts and establishing natural gas conservation cost recovery factors determined to be appropriate in this proceeding?

SJNG's Position: Yes

Issue 7: What should be the effective date of the new conservation cost recovery factors for billing purposes?

SJNG'S Position: The effective date should be January 1, 2020.

Issue 8: Should this docket be closed?

SJNG'S Position: Yes sir
