INTERROGATORIES (NOS. 18-31)**

Duke Energy Florida, LLC ("DEF" or the "Company"), pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code (F.A.C.), submits this Notice of Intent to Request Confidential Classification of documents provided in DEF's Response to the Office of Public Counsel's ("OPC") Fourth Set of Interrogatories (Nos. 18-31). Confidential responses have been filed with the clerk and the redacted versions have been filed as part of DEF's Responses to respective requests. Specifically, DEF's responses to Interrogatory Nos. 23 and 27 contain confidential proprietary business information, relating to specific contractual terms and third-party information.
