Staff is requesting approval to make an oral modification to its recommendation filed in Docket No. 20190118-WU, Application for increase in water rates in Gulf County by Lighthouse Utilities Company, Inc. (Lighthouse Utilities or Utility) currently scheduled for the October 3, 2019 Agenda Conference. Staff's proposed modifications relate to the Utility waiving the statutory deadline to suspend final rates in this docket.

As a result of Hurricane Dorian's potential threat to areas of the State of Florida, the September 5, 2019 Agenda Conference was cancelled. The 60-day statutory deadline for the Commission to suspend final rates was September 10, 2019. By letter dated September 5, 2019, Lighthouse Utilities agreed to waive the Commission's statutory deadline under 367.081(6), Florida Statutes, to withhold consent to the operation of the Utility's request for a rate increase in Docket No. 20190118-WU to October 3, 2019.

These changes do not affect staff's recommendation to suspend final rates.

Case Background - Last Paragraph on Page 2:

The 60-day statutory deadline for the Commission to suspend Lighthouse's requested final rates is September 10, 2019. On September 5, 2019, the Utility filed a letter waiving through October 3, 2019, the Commission's deadline to suspend Lighthouse's requested final rates in this docket. This recommendation addresses the suspension of Lighthouse's requested final rates. The Commission has jurisdiction pursuant to Section 367.081. Florida Statutes (F.S.).

Staff Analysis – First Paragraph under Staff Analysis on page 3:

Staff Analysis: Section 367.081(6), F.S., provides that the rates proposed by a utility shall become effective within sixty days after filing unless the Commission votes, for good cause, to withhold consent of implementation of the requested rates. As noted in the Case Background, Lighthouse Utilities has waived the deadline of September 10, 2019, to October 3, 2019. Further, Section 367.081(10), F.S., permits the proposed final rates to go into effect under bond, escrow, or corporate undertaking five months after the official filing date unless final action has been taken by the Commission or the Commission's action is protested by the Utility.
