My power comes on cords from my pole because I have No Idea how to get it reconnected in my walls when 2 room was cut off. The Companies Officer should do Everything they can to Help Us. But maybe they don't live here .They should.

Also power drives our wells. I got my water back at about the same time. It's outside from faucets & in a big sink out back I can hardly walk to. I "bathe" with a washcloth at the front faucet. I sorta get clean. I wash my clothes there too & line dry them. Channeling my Pioneer. I save rainwater too. The dear lady who came out from FPU & Saved Us by saying shed seen where some folks had ruined rooms turned into outside Access rooms told me she saved rainwater for her pets & was wearing many pairs of pants just like I was. I gave the rain to my pets just like she did. My water was donated. I Still Flush with a Bucket. But I'm Grateful because I'm Lucky. So many are so much worse off than I am. We Still Need Help!

I am writing to urge you to reject the request by Florida utilities to have a goal of zero (or nearly zero) on energy efficiency for the next ten years.

I am concerned that if the energy efficiency goals are abandoned, the utilities will stop providing the kinds of services that help people lower their power bills. People shouldn't have to choose between paying for food, medicine, or rent and being comfortable in their own homes.

Florida is ranked near the bottom of the nation in terms of energy efficiency — we should be increasing energy efficiency measures, not abandoning them. We know that increasing energy efficiency is one of the cheapest and easiest ways to fight the global warming that's causing neighborhood flooding and other serious problems in Florida.

When this issue comes back before you, I ask you please to vote to strengthen our energy efficiency goals.
