Re: Docket No. 20190185-WS - Application for authority to transfer assets of exempt entity in Sumter County by the City of Wildwood to South Sumter Utility Company, LLC.

Dear Mr. Friedman:

Staff reviewed the draft notice provided with the application for authority to transfer assets of exempt entity in Sumter County by the City of Wildwood to South Sumter Utility Company, LLC (SSU).

To obtain Commission approval of its notice, SSU should make the following changes to its notice:

1. Rule 25-30.030(3)(f), Florida Administrative Code, (F.A.C.), requires that the notice should be titled "Notice of Application for Authority to Transfer Assets of an Exempt Entity to a Regulated Utility." Please amend the notice to add the words "Notice of" to the beginning of the title.
2. Rule 25-30.030(4)(b), F.A.C., requires that the notice contain the name, address, telephone number, and, if available, email address and fax number of the applicant. Please amend the notice to include the email address and fax number of the applicant. If not available, please state that it is not available.
3. Rule 25-30.030(4)(d), F.A.C., requires that the notice include the application docket number and title. Please amend the notice to contain the docket number.
4. Rule 25-30.030(4)(e), F.A.C., requires that the notice include the common reference of street names bordering the area served by the utility, if applicable. It is clear that County Road 468 borders the area being served to the north. Please amend the notice to provide the common local reference of this street name, and others if applicable.

5. Rule 25-30.030(4)(g), F.A.C., requires that the notice include a statement that the utility is not requesting any changes to its rates, classifications, charges, rules, and regulations in the application. Please amend the notice to include this statement.

Please make the changes noted in items 1 through 5 above and submit the corrected notice to the Office of Commission Clerk, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, referencing Docket No. 20190185-WS, no later than **November 22, 2019**.
