We appreciate the opportunity to provide comments on Florida Power and Light's SolarTogether proposal, a program that we look forward to supporting as a program participant.

Resolute Forest Products is a global leader in the forest products industry with a diverse range of products, including market pulp, tissue, wood products, newsprint and specialty papers, which are marketed in close to 70 countries. The company operates two tissue mills in Florida that are both in the service area of FP&L.

As a company, reinforcing our environmental credentials by taking appropriate steps to responsibly manage climate change is a primary area of focus of our sustainability strategy. At the end of 2018, we had reduced the company's scope 1 and 2 absolute greenhouse gas (GHG) emissions by 81% relative to 2000 levels.

We focus on improving energy efficiency and replacing high-emission fuels, like coal, with less carbon-intensive options. In 2018, we sourced 74% of our total energy (electricity and fuel) needs from renewable sources, including biomass and hydroelectricity.

In 2014, we replaced the remaining coal used at our operations with natural gas, a less-carbon-intensive fuel, in order to become scope 1 coal-free as of April 2014.

We plan to build on our progress by capitalizing on the programs of FP&L and the opportunity to purchase green energy to power our Florida operations.
