PURPOSE AND PROCEDURE

The purpose of this workshop is to discuss current enforcement authority and activities related to excavation damage to underground natural gas facilities. The workshop will also be a forum to discuss trends in excavation damage (i.e. number of incidents, root cause of damage, monetary impact, and utility response). The workshop may also be a forum to discuss Sunshine 811's options to address enforcement over excavation damage.
