Good morning. Just wanted to follow-up on the status of Cedar Acres' meter replacements. As of your escrow reimbursement request dated February 8, 2019, you indicated that 170 meters had been replaced.

1. Have any additional meters been replaced since then? Yes.
2. If so, how many have been replaced and when did the replacements take place? 24 meters were replaced in March/April of 2019 for a total of 194 replacements.
24 meters are currently on order and should be replaced in September.
3. If no additional meter replacements have been made since February 2019, when will the next batch of meters be replaced? As part of your response, please explain any delay.

4. Is the utility on track to complete all meter replacements within the four-year time frame established by the Commission in Order No. PSC-2015-0535-PAA-WU?

We expect to have the meters replaced within the time frame established. The 24 meters to be replaced in September will put us at about 70% completion.
