Service Commission (“Commission”) of their entry into Chapter 11 bankruptcy protection.

Telecom Holdings LLC (together, the “Parties”), filed the above-referenced notice of a  
reorganization transaction in which controlling interest in the Fusion Entities would be acquired
