Subject: Split Option of 813 NPA

---

This is to inform you of a split option of the FL 813 NPA requested by the Florida Public Service Commission Staff (Commission) which will be presented during the upcoming public meetings in February. It is understood that NANPA did not present this alternative at the relief planning meeting and the industry only recommended the overlay. However, the Commission staff wishes to present both an overlay and a geographic split option to the public.

The split line runs North to South between Tampa North and Zephyrhills; Plant City and Tampa East. Tampa East, Tampa North, Tampa Central, Tampa West and Tampa South would remain on the west side of the split. Zephyrhills and Plant City would be on the east side of the split. Area A would include rate centers: Tampa East, Tampa North, Tampa Central, Tampa West and Tampa South. Area B would include rate centers: Zephyrhills and Plant City. The projected lives of the two areas are 4 years for Area A and 264 years for Area B with a difference of 260 years. This split alternative does not meet the criteria set forth by the INC NPA Code Relief Planning and Notification Guidelines,

**Section 5.0 (g): In the long term, the plan shall result in the most effective use possible of all codes serving a given area. Ideally, all of the codes in a given area shall exhaust about the same time in the case of splits. In practice, this may not be possible, but severe imbalances, for example, a difference in NPA lifetimes of more than 10 years, shall be avoided.**
