To Members of the Commission:

I am Commissioner Emily Bonilla, Orange County, Florida, District 5. I am writing to express concern with the recent notice of a rate increase sent by Pluris Wedgefield, LLC (Pluris, LLC) to the residents in Wedgefield, Florida. On June 15, 2020, residents were notified that their water rates would increase by approximately 1.01% and wastewater by 1.15%.

Upon conversation with staff at the Florida Public Service Commission (FPSC), I understand that this increase is due to an annual administrative price indexing for certain noncontrollable expenses subject to inflationary pressures such as chemicals and other general operation and maintenance costs. Although we understand the logistics of such an increase, the Wedgefield community's impression is that Pluris, LLC, continues to raise their rates, even amid a national pandemic.

The citizens of Wedgefield again feel duped and taken advantage of by Pluris, LLC. I would be remiss if I did not express my frustration with the high rates charged by this private utility company. Although this price index is small, overall, the residents of Wedgefield are paying 147% higher rates than Orange County charges its customers. Furthermore, of the approximately eighty (80) PFSC-regulated combined water and wastewater utilities in Florida, Pluris, LLC is among the top 10 of the highest rates charged to its customers.

Due to the exorbitant rates Pluris, LLC charges its customers, Orange County is in negotiations to buy out this utility. This buy-out's sole purpose is to relieve the citizens of Wedgefield of the constant rate increases, even though it is not necessarily cost-effective for the county to do so.

I will continue to champion the effort of Orange County gaining control of the water and wastewater in Wedgefield. Until that effort has ceased, I will continue to voice my opposition to any rate increase, price indexes included, to the residents of Wedgefield. Therefore, please allow this letter to serve as my formal opposition to the price index rate increase.
